

GUIDE TO INFORMATION AVAILABLE THROUGH STRATHCLYDE PARTNERSHIP FOR TRANSPORT'S PUBLICATION SCHEME

The Freedom of Information (Scotland) Act 2002 (the Act) requires Scottish public authorities to produce and maintain a publication scheme. Authorities are under a legal obligation to:

- publish the classes of information that they make routinely available; and
- tell the public how to access the information and what it might cost.

Strathclyde Partnership for Transport has adopted the [Model Publication Scheme](#) (updated November 2018) produced by the Scottish Information Commissioner.

The purpose of this Guide to Information is to:

- allow the public to see what information is available (and what is not available) in relation to each class;
- state what charges may be applied;
- explain how to find the information easily;
- provide contact details for enquiries and to get help with accessing the information; and
- explain how to request information we hold that has not been published.

1. Availability and formats

The information we publish through the model scheme is, wherever possible, available on our website. We offer alternative arrangements for people who do not want to, or cannot, access the information online or by inspection at our premises. For example, we can usually arrange to send information to you in paper copy (although there may be a charge for this - see charges below).

You can also contact Strathclyde Partnership for Transport at the address below if you would prefer a copy of the Model Publication Scheme (updated November 2018) or this Guide to Information to be provided to you in a different format.

2. Exempt information

We will publish the information we hold that falls within the classes of information below. If a document contains information that is exempt under Scotland's freedom of information laws (for example sensitive personal information or a trade secret), we will remove or 'black out' the information before publication and explain why.

3. Copyright and Re-Use

Commercial exploitation or reproduction of material published in terms of this scheme is prohibited. Where Strathclyde Partnership for Transport holds the copyright in its published information, the information (except logos) may be copied, reproduced, used and/or re-used without formal permission, subject to terms of the Non-Commercial Government Licence for public sector information ("the Licence").

The Licence is a simple set of terms and conditions that allow the re-use of information free of charge. By re-using published information in which Strathclyde Partnership for Transport holds the copyright, you accept the terms and conditions of the Licence. Please contact Strathclyde Partnership for Transport for a paper copy of the Licence, if required.

If you wish to re-use published information in a way that is not compatible with the Licence, a formal request for re-use should be submitted to Strathclyde Partnership for Transport. Your request will be considered under the Re-Use of Public Sector Information Regulations 2015 ("RPSIs") for which a charge may be imposed. In the event that a charge is payable, you will be advised what this is and how it has been calculated. If you would like more information on the RPSIs, please contact the address below.

The Licence does not cover the use and/or re-use of published information in which Strathclyde Partnership for Transport does not hold the copyright in information. If Strathclyde Partnership for Transport does not hold the copyright in the published information, we will make this clear.

Information provided on CD-Rom will be charged at £1.00 per computer disc.

Postage costs will be recharged at the rate we pay to send the information to you. Our charge is for sending info by Royal Mail First Class.

When providing copies of pre-printed publications, we will charge no more than the cost per copy, pro rata, of the total print run.

We do not pass on any other costs to you in relation to our published information.

Please note that this charging schedule does not apply to our commercial publications (see Class 8 below). These items are offered for sale through retail outlets such as book shops, academic journal websites or museum shops and their price reflects a 'market value' which may include the cost of production.
