## **Minute of the meeting of the Strathclyde Partnership for Transport held in the Lewis Room, 131 St Vincent Street, Glasgow, on 7 October 2016**

## 6. Membership update

Mrs Davidson informed members of the undernoted changes to representation on the Partnership:-

The Partnership noted the position and agreed that both members be appointed to the committees on which their predecessors had served.

## 7. Glasgow City Region Deal

With reference to the minute of the Strategy & Programmes Committee of 27 March 2015 (page 4, paragraph 9) when that committee, inter alia, had approved the key project elements of the Strathclyde Bus Investment Programme (SBIP) draft Strategic Business Case for submission to Glasgow City Region City Deal, there was submitted a report (issued) of 21 September 2016 by the Assistant Chief Executive (Operations)

- (1) informing members
  - (a) that, as the SBIP was one of the key regional projects of the City Deal, officers had sought to engage with partners and had continued to develop further the proposals to ensure that the SBIP was as complementary as possible to other City Deal projects;
  - (b) that, in doing so, it was anticipated that it would maximise opportunities for generating sustainable economic growth, an aspiration central to the success of the City Deal; and
  - (c) that, in line with City Deal guidance, SPT's initial step in developing the final Strategic Business Case (SBC) had been to identify demand-based sectors across the city region where attention could be focused for future delivery of the SBIP;
- (2) explaining
  - (a) that an exercise had been undertaken to profile each of the sectors in relation to current transport services, socio-economic issues, route hotspots, congestion points, current development proposals and other factors, which had helped to build a base position from which the SBIP could be refined to create a complementary, deliverable programme of interventions;
  - (b) that, in addition, SPT officers had presented an update on the SBIP to the City Deal Chief Executives' Group to raise the profile of the project and had received useful feedback; and
  - (c) that building on this engagement, officers were in the process of preparing the full final SBC for the SBIP which would be submitted to the City Deal Programme Management Office within the deadline of 28 October 2016;

- (3) detailing the key elements of the final SBC which would form the focus of initial SBIP investment (subject to due process and necessary approvals) which would seek to address the totality of investment required across the city region;
- (4) intimating that, where possible, SPT would seek to ensure that partners, or those who benefited from SBIP investment, would become members of any future Statutory Quality Partnership (or any variation thereof) for their area or the region e.g. the Strathclyde Bus Alliance; and
- (5) recommending that the Partnership approve the key elements of the final SBC which would form the basis of the SBIP to be submitted to the City Deal.

After consideration and having heard Mr Kiloh in answer to members' questions, the Partnership approved the recommendation at (5) above.

## **8. Presentation: Glasgow City Centre Bus Improvements**

There was introduced to the meeting Gordon Dickson, Bus Development Manager, who gave a presentation on proposed bus improvements in Glasgow city centre.

He highlighted the current problems within the city centre, viz. bus/traffic congestion which caused delays and increased emissions, complex junctions and bus movements and poor facilities for bus users within the Union Street/Jamaica Street/Oswald Street corridor.

Mr Dickson then provided members with information on a number of interventions, including improved public realm and lighting, modifying bus routes, simplifying junction lanes and signals, widening footways and providing new shelters and real time passenger information which would reduce bus service delays, improve traffic, pedestrian and passenger safety, reduce emissions and improve the public realm and general environment.

He advised that the first phase had a completion date of December 2016 and phase two would be completed in Spring 2017.

Following considerable discussion and having heard Mr Dickson in answer to members' questions, the Chair, on behalf of the Partnership, thanked him for his presentation.
